#### Ireland in international business

Ireland is a long established EU State with a skilled, well-educated workforce. Dublin is recognised as a well established international financial centre.

Ireland is a common law jurisdiction, and its concepts are recognised by most investors with laws relating to personal property and transfer of assets being similar to that of the UK and US.

Ireland is also home to a very varied population of international professionals.

Ireland has competitive corporate income tax rates, and double tax treaties with over 50 countries, of which 46 are in-force. Ireland is also considered a gateway to Asia/China due to the Ireland/China tax treaty, and is fast becoming a main point of entry for US companies into the EU.

Additionally, Ireland has one of the lowest rates of corporation tax in the EU for trading activities, with extensive domestic exemptions i.e.: 0% withholding tax on payment of dividends to EU or tax treaty countries, 0% on capital gains tax on disposal of shareholdings in subsidiaries, and 0% on interest withholding tax.

The incorporation of an Irish company can be realized quickly and efficiently.
